Have intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop the research study.

#### AND/OR

Make provisions for research and for the advancement and dissemination of knowledge

#### AND/OR

To organize and to undertake extra-mural studies and extension services

#### A. FIELD OF CO-OPERATION:

1. Both the DBCOP and GAHT shall evolve a mutually acceptable schedule to develop programs, hold seminars and visits.

- 2. The said academic interaction and intellectual assimilation may include:
  - i. Faculty/staff development
  - ii. Deputing PG students as a project trainee with/without stipend at suitable organization
  - iii. Organizing seminars, research, conferences and workshops with mutual consents
  - iv. Collaborations in the sharing of academic data, scientific information, intellectual property, articles and publications
  - v. Providing assistance for the training and placements of UG & PG students.

# B. BENEFIT TO STAFF/STUDENTS/TEACHERS:

- 1. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects.
- 2. The GAHT will provide the required raw inputs for the proposed research work like plant characteristics etc. to the DBCOP to enable individual selected students to carry out the experimental works on the collaborative research.
- 3. The GAHT will have the first right of refusal to shortlist the third year/ final year graduate/post-graduate students for such collaborative research works.
- **4.** The decision of the GAHT in terms of selection of a particular student for a particular topic / subject will be final.
- 5. Students of DBCOP can enroll for short term training for 4 to 6 weeks as part of their curriculum will receive a suitable certificate on completion of the training program
- **6.** Students desirous of working on their projects on a medium long term basis for 6 to 18 months will be required to visit the GAHT collaborated facilities often.
- 7. The DBCOP will ensure that the selected student has not been awarded any assignment by any other organization / DBCOP for any research work.
- **8.** All students will be required to sign a non disclosure agreement (NDA) with the GAHT prior to taking up the assignment on the collaborative research work.
- 9. The DBCOP will not engage with any other commercial organization for such work that will imply competition with the product range of the GAHT.
- 10. The GAHT has authorized its Technical Officer of the group to take all decisions as deemed appropriate to make this MOU a success.
- 11. Both parties either through the students and / or their respective supervisors / Research guides, or in any manner will not disclose to a third party without proper authorization, any matter pertaining to the collaborative research work.

**14.** The GAHT will nominate a suitable co-author for technical papers if any published in journals of repute on the success of the collaborative research work. The decision of the GAHT on the contents of the technical paper will be final.

### C. SUPPORT TO RESEARCH LAB:

For promoting the industry – DBCOP collaboration, the GAHT will help to establish the research lab within the campus of the DBCOP. Support to research lab may include supply of APIs, polymers, some instruments and accessories thereof. The maintenance of all the machineries or equipments provided by the GAHT will be the sole responsibility of the DBCOP. This lesion will help the DBCOP to enhance student's knowledge base with respective to the current industrial operations. It will be also helpful to the GAHT for conducting their projects where they could utilize the manpower form the DBCOP and reduce the burden on their existing machineries and manpower available at the GAHT.

#### D. MISCELLLANEOUS:

- 1. The details for the efficacious implementation of this MOU shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the organizations.
- 2. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and condition(s) of this agreement.
- 3. The MOU shall remain in force for a period of FIVE years from the date of its signature and seal, and may be terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- **E.** The parties to this MOU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- **F.** This MOU shall require the ratification of the competent academic/executive body of both the organizations.
