Have intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop the interdisciplinary research.

#### AND/OR

Make provisions for research and for the advancement and dissemination of knowledge

#### AND/OR

To organize and to undertake extra-mural studies and extension services

## A. FIELD OF CO-OPERATION: -

- 1. Both, DBCOP and Shri Ayurved Mahavidyalaya shall evolve a mutually acceptable schedule to develop programs, hold seminars and exchange visits.
- 2. The said academic interaction and intellectual assimilation may include:
  - i. Faculty/staff development and exchange
  - ii. Deputing PG students as a project trainee with/without stipend
  - v. Organizing seminars, research, conferences and workshops with mutual consents
  - vi. Collaborative interdisciplinary research
  - vii. Sharing of academic data, scientific information, intellectual property, articles and publications

# B. EXCHANGE OF STAFF/STUDENTS/TEACHERS: -

- 1. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects either sponsored or non-sponsored
- 2. The **Shri Ayurved Mahavidyalaya** will provide the required raw inputs for the proposed research work to **DBCOP** to carry out the experimental works on the collaborative research and vice versa.
- 3. Interdisciplinary projects can be operated by research coordinators of both **Shri Ayurved Mahavidyalaya** and **DBCOP**, after the signing of confidential agreement of the said project.
- 4. Faculty members of **DBCOP** with the written consent of **Shri Ayurved Mahavidyalaya**, can apply for the funding for collaborative projects to various funding agencies as a principal investigator (PI) and co-PI
- 6. The output of collaborative research can be published/patented/commercialized with mutual consent mentioning names of research coordinators of both Shri Ayurved Mahavidyalaya and DBCOP

- 7. This intellectual property will belong to both **Shri Ayurved Mahavidyalaya** and **DBCOP** and same should not be utilized for any techno-commercial use by any party without prior written consent of the other counterpart.
- 8. The students and faculty members from **DBCOP** and **Shri Ayurved Mahavidyalaya** will have freedom to use the existing facilities of both parties including instruments and other consumables.
- 9. **Shri Ayurved Mahavidyalaya** and **DBCOP** should authorize its research coordinator to take all decisions as deemed appropriate to make this MoU a success.
- 10. Both **Shri Ayurved Mahavidyalaya** and **DBCOP**, either through the students and / or their respective supervisors / research guides or in any manner will not disclose to a third party without proper authorization, any matter pertaining to the collaborative research work.
- 11. Teachers, researchers, guides and students from **DBCOP** and **Shri Ayurved Mahavidyalaya** shall be encouraged to work in tandem in the laboratories, workshops, hospital facilities and departments of both the organizations.

#### C. MISCELLLANEOUS: -

- 1. The details for the efficacious implementation of this MoU shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the organizations.
- 2. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and condition(s) of this agreement.
- 3. The MoU shall remain in force for a period of three years from the date of its signature and seal, and may be terminated by either side by giving six months' notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- E. The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance.

The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

**F.** This MoU shall require the ratification of the competent academic/executive body of both the organizations.
