MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is signed between:-

AND

Siddhayu Ayurvedic Research Foundation Pvt. Ltd. Nagpur., located at Bahadura, Kalmana (Acharya), Umrer Road, Nagpur, Maharashtra - 441204

This MoU has been signed with an objective to disseminate and advance knowledge by providing instructional, research and extension facilities in the field of Pharmaceutical Sciences as it may deem fit and it shall endeavor to provide students, staff and other stakeholders the necessary atmosphere and facilities for the promotion of:

- i. Innovations in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality.
- ii. Inter-disciplinary and multi-disciplinary research protocols.
- iii. Applied and advance knowledge of medical science to the field of Pharmacy.
- iv. Sharing of infrastructure, chemicals, staff, students, books and journals, etc.
- v. Organising conferences, workshops, seminars for dissemination of current knowledge in the field of Pharmaceutical Sciences.
- vi. Training to students and staff for upgrading their knowledge and skills.

AND

Siddhayu Ayurvedic Research Foundation Pvt. Ltd., located at Bahadura, Kalmana (Acharya), Umrer Road, Nagpur, Maharashtra - 441204

Herein refer as "**Siddhayu Ayurvedic Research Foundation**"

Have intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop the interdisciplinary research and training.

AND/OR

Make provisions for research and for the advancement and dissemination of knowledge

A. FIELD OF CO-OPERATION:-

1. Both, **DBCOP** and **Siddhayu Ayurvedic Research Foundation** shall evolve a mutually acceptable schedule to develop programs, hold seminars, training and exchange visits.
2. The said academic interaction and intellectual assimilation may include:-
 - i. Faculty/staff development and exchange
 - ii. Deputing PG students as a project trainee with/without stipend
 - vii. Organizing seminars, research, conferences and workshops with mutual consents
 - viii. Collaborative interdisciplinary research
 - ix. Sharing of academic data, combined intellectual property, articles and publications
 - v. Providing assistance for the training and placements of UG & PG students

B. EXCHANGE OF STAFF/STUDENTS/TEACHERS:-

1. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects either sponsored or non-sponsored
2. The **Siddhayu Ayurvedic Research Foundation** will provide the required raw inputs for the proposed research work to **DBCOP** to carry out the experimental works on the collaborative research.
3. Interdisciplinary projects can be operated by both **Siddhayu Ayurvedic Research Foundation** and **DBCOP**, after the signing of confidentiality agreement of the said project.

4. Students and faculty members of **DBCOP** can be deputed for short term training programs of one to two weeks and will receive a suitable certificate on completion of the training program.
5. Faculty members of **DBCOP** with the written consent of **Siddhayu Ayurvedic Research Foundation** can apply for the funding for collaborative projects to various funding agencies as a principal investigator (PI) and co-PI.
6. The output of collaborative research can be published/patented/commercialized with mutual consent mentioning names of research coordinators of both **Siddhayu Ayurvedic Research Foundation** and **DBCOP**
7. This intellectual property will belong to both **Siddhayu Ayurvedic Research Foundation** and **DBCOP** and same should not be utilized for any techno-commercial use by any party without prior written consent of the other counterpart.
8. The students and faculty members from **DBCOP** and trainees and executives of **Siddhayu Ayurvedic Research Foundation** will have freedom to use the existing facilities of both parties including instruments and other consumables with prior approval from management of **Siddhayu Ayurvedic Research Foundation**.
9. **Siddhayu Ayurvedic Research Foundation** and **DBCOP** should authorize its research coordinator to take all decisions as deemed appropriate to make this MoU a success.
10. Both **Siddhayu Ayurvedic Research Foundation** and **DBCOP**, either through the students and / or their respective supervisors / research guides or in any manner will not disclose to a third party without proper authorization, any matter pertaining to the collaborative research work.
11. Teachers, researchers, guides and students from **DBCOP** and trainees and executives of **Siddhayu Ayurvedic Research Foundation** shall be encouraged to work in tandem in the laboratories, workshops, industrial facilities and departments of both the organizations.

C. MISCELLANEOUS:-

1. The details for the efficacious implementation of this MoU shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the organizations.
2. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and condition(s) of this agreement.
3. The MoU shall remain in force for a period of three years from the date of its signature and seal, and may be terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

E. The parties to this MoU undertake to treat information relating to business, trade secrets, activities, proprietary information, employees and overall functions of the other institutions as **CONFIDENTIAL AND PRIVILEGED**. The information disclosed during the course of this relationship shall be treated with confidentiality and care. Any deviation of the parties from this clause shall be treated as breach of this agreement.

F. This MoU shall require the ratification of the competent academic/executive body of both the organizations.
